Seasons' Greetings to All:

We hope you have noticed that Springfield is undergoing a physical revival of late. For instance, the McDonalds has been refurbished and the Backlick Road Shell has begun its renovations. The local Five Guys restaurant is undergoing a similar upgrade.

Construction on the new headquarters (HQ) for the Transportation Security Administration has begun while construction of The St. James Sports Complex on Industrial Drive (former Washington Gas HQ) continues apace with a promised opening in September. Hampton Hotels is planning to build on the former Merv's Auto Repair site near the Motel Six, and LIDL is moving ahead with their plan to build a grocery store on the corner of Brandon and Commerce Street (formerly Safford Dodge). The Town Center is also involved as Dave & Buster's is looking to expand along with Maggiano's. The County, Lee District Supervisor McKay and his Staff are working to facilitate and keep this momentum. Most encouraging of all is the private equity investment in Springfield, a definite nod to Springfield's future commercial viability.

Supervisor McKay's Year in Review

Many big changes came to Lee District and Fairfax County this year, and many of those changes benefit our ongoing revitalization efforts and improve the way we deliver services to residents. Thanks in no small part to our community's hard work, it was overall a strong year for Lee District and Fairfax County as a whole.

My proudest legislative accomplishment was the passage of the OneFairfax Resolution; an affirmation by the Board of Supervisors to improve equity of access to opportunity for all residents regardless of their background. In my mind, this was one of the most important resolutions that has come across my desk in my term as Supervisor, and there has never been a more important time to commit to reducing inequalities in our community. The resolution first began to develop during one of my meetings with the Successful Children and Youth Policy Team, and grew from there to be an unwavering commitment to a better future for all residents. After all, much of Fairfax's economic success has been because we are inclusive and we need to enhance that further.

Even in the wake of the FBI cancelling its headquarters relocation, I was confident that we would be able to attract other federal agencies to Springfield. That paid off when I learned that the Transportation Security Administration had chosen to build their new headquarters near the GSA warehouse, a testament to our hard work. In just the past few years, Springfield has become a major economic powerhouse in the region with the Springfield Town Center becoming the third most valuable property in Fairfax.

I also was able to work together with Mount Vernon Supervisor Dan Storck to get transportation projects in Lee District and along the Route One Corridor put at the top of the priority funding request the Board of Supervisors recently approved. In all, projects in Lee District made up 43.8% of the total projects listed on the countywide funding request. This request is a major step forward in that direction. We were also able to get many Lee District roads on the VDOT paving plan, ensuring that residents would be able to travel on wellmaintained and safe roads.

We also had big developments in our parks this year. Franconia Park, a stone's throw from my office, is currently having its master plan re-evaluated, a major step in adding new facilities and features to one of our favorite neighborhood parks. We also brought back the carousel to Lee District Park, a childhood favorite of mine and a staple of summers in Lee District. In public safety news, police in the Mount Vernon Station will begin wearing body-worn cameras for a pilot program in the next few months, after the Police Ad Hoc Commission made a recommendation to the Board of Supervisors. A research team will evaluate the impact of the cameras and report back after the three month pilot program, after which we will make a decision on whether to keep the cameras as a permanent program. Many agencies and organizations were involved in this exciting project, including our own police department and sheriff's office, the Fairfax NAACP, the Independent Auditor's Office, and many community organizations.

Even more is on the horizon for Lee District and its residents. As we move into 2018, I am already hard at work looking for opportunities to continue to improve our quality of life and offer even more great services. It was a pleasure serving as your District Supervisor this year.

Lake Accotink News

Lake Accotink Park hosted approximately 200 people for its annual Holiday Horse-drawn Hayrides, held on December 9, 2017 amidst a light snowfall and a landscape worthy of a holiday greeting card. A flatbed wagon pulled by two Belgian draft horses picked up 15 to 20 passengers every 20 minutes and carted them along the park road past the lake and the dam. Participants also enjoyed visits with Santa in his cozy cottage that other times of year serves as the park's camp office. A crackling campfire by the lake with plenty of s'mores to go around warmed the spirits of attendees as they listened to music of the season that was playing over the carousel sound system. We are extremely grateful to *Friends of Lake Accotink Park* for providing volunteers to help with the event.

With the holiday event behind us, park staff are working on plans for a "*Birds and Bats*" event that is scheduled for Saturday, April 28, 2018. The program is designed to celebrate the important roles that birds and bats play in the ecosystem. News from the Chamber of Commerce

Chamber Honors Meg Brantley with Herb Hunter Award

An executive director who oversees approximately 400 workers — for free — is the Greater Springfield Chamber's Herb Hunter Citizen of the Year. Meg Brantley, the Chamber's 2017 Herb Hunter recipient, is executive director of the nonprofit Ecumenical Community Helping Others (ECHO).

Others recognized by the Greater Springfield Chamber for their community dedication were Fairfax County Fire & Rescue Master Technician Michael Guck, Public Service Award; April Pinch-Keeler, Business Person of the Year; and Andrews Federal Credit Union, Corporate Citizen.

After having served as a co-chair of ECHO's clothing services for 10 years, Brantley accepted the challenging job of executive director in 2009. Since then, she has guided ECHO's mission of providing food, clothing and emergency financial help to people in need. Because ECHO is staffed entirely by volunteers, Brantley's full-time job has been without remuneration.

Along with a penchant for hard work, Brantley has brought a commitment to the ideal that clients, donors and volunteers be treated with dignity and fairness. She works with and supervises approximately 400 volunteers whose tasks include everything from packing bags of food, to sorting thousands of donated clothing items and household goods, to making sure the physical plant works properly. Directing the work of volunteers requires a measure of grace and tact, qualities Brantley possesses in abundance. In addition, Brantley works closely with the ECHO board and community and government officials. Her outstanding organizational abilities are matched with a great sense of humor and touching personal warmth – qualities that have helped ECHO increase its volunteer staff and its number of donors during her tenure and qualities that earned Brantley this year's prestigious Herb Hunter Citizen of the Year award.

Guck, the Public Service Award recipient, has been the driver/operator of Franconia Tower Ladder 405 since June of 2014, is the master technician on B-shift and takes the lead on most of the training at the station. He is an EMT-Intermediate and a Hazardous Materials Technician on the county's Hazardous Materials Response Team and holds instructor certifications in multiple disciplines. Within the past three years Guck has been involved in the technical rescue of trapped riders on a roller coaster at Six Flags Amusement Park in Prince Georges County, MD, assisted in the fire suppression and rescue of trapped occupants at a garden apartment fire on Mary Caroline Circle, and assisted in the delivery of two babies as a Firefighter/Medic on both Tower 405 and Medic 405.

Under Pinch-Keeler's leadership, MVLE has forged partnerships with more than 125 business, government and community organizations across our region to support individuals with disabilities, expanded to three Community Centers and launched countless new programs and business lines. Among her many accomplishments, Pinch-Keeler's vision, energy and persistence resulted in MVLE becoming the first nonprofit accepted into the national Department of Defense Mentor Protégé Program, with Northrup Grumman Corp. as MVLE's mentor. MVLE's participation in the DoD Mentor Protégé Program is trailblazing as it is the first-ever acceptance of a nonprofit into the program. By accomplishing entry into the Mentor Protégé program, Business Person of the Year Pinch-Keeler has opened the doors for the national AbilityOne Program and all non-profits to secure employment for people with disabilities within the DoD.

Founded in 1948, Corporate Citizen of the Year recipient Andrews Federal Credit Union has gone above and beyond to be involved in and support the Greater Springfield community since it opened its first branch in the Springfield Town Center in 2014. Andrews staff is encouraged to participate in civic organizations and support community causes – and they do. Among their community involvement is partnering with the Friends of Richard Byrd Library to lead free, financial education seminars; volunteering with Lorton Community Action Center service projects; volunteering for Fairfax County's Summer Lunch Bunch program; and scraping, cleaning and repainting 12 fire hydrants along King Street in Alexandria. In addition, Andrews was the presenting sponsor of Springfield Days 2017, our community's all-volunteer run and supported annual festival. Andrews also served as a community sponsor for the Tots2Tweens Back2School Bash at the Springfield Town Center.

Citizens Advisory Committee—CAC

CITIZENS' ADVISORY COMMITTEE FRANCONIA DISTRICT POLICE PARTNERSHIP WITH THE COMMUNITY

To enhance its ability to communicate with and better serve the community, the Fairfax County Police Department (FCPD) established a program in 1979 which took the form of advisory groups known as Citizens' Advisory Committees (CAC).

The purpose of the CAC is to:

- provide an organized forum for direct communication between the Police Department and the community on emergencies and matters of community and/or personal concern.
- help the Police Department and the community work toward a common goal of crime prevention through citizen concern and improved police services.

 support the Police Department, where appropriate, before pertinent legislative bodies and government agencies.

The Franconia Citizens' Advisory Committee meets the third Wednesday of the month at 7:00 pm at the Franconia Government Center. After a presentation/program by someone from a department of the FCPD and a short break, the Chair conducts a brief information-sharing and business meeting. The "Officer of the Quarter" (after being selected by the CAC membership) is recognized for his or her outstanding service followed by "Tell It to the Captain".... the point where communication happens between the police and the community.

There is no annual fee to be a member of the CAC. However, Civic Associations, Homeowners Associations, and individuals often make donations to the CAC which help with special meals we provide to officers who have to work on holidays; the CAC also makes contributions to the station for items that their budget may not cover. These donations are wonderful but secondary; primary is the communication and connection between the police and each of the communities.

Note: The CAC organized meals for those officers working on Thanksgiving, Christmas Eve, and Christmas Day. With huge food contributions from GreenSprings, donations from Civic Associations like North Springfield and the SCA, and volunteers from the CAC, the officers didn't go hungry or have to be alone on the holidays!

Fairfax Water Tips

The freezing temperatures could lead to frozen pipes or frozen meters. Fairfax Water has offered these tips to keep you safe this winter.

Winter Water Tips

There are several measures that can be taken to prevent winter water disasters.

It is a good idea to locate and mark your main-line valve and check it for proper operation. This valve controls water flowing into your home and is usually found near where the water line that comes into your house. Marking the valve will allow you to quickly turn off the water if a pipe should burst or you have other water problems. You can request a tag to mark the valve at by calling 703-289-6019, TTY 711. You can also download and print a tag by going to http://www.fairfaxwater.org/current/Main%20Line%20Water%20Valve%20tag%20for%20Web.pdf.

• Make sure the water line to outside faucets is turned off and the line is drained. Drain each outdoor spigot after turning off the valve to prevent any remaining water from freezing and bursting the pipes. Some spigots have anti-siphon devices that must be opened to properly drain the line.

• Eliminate drafts. Check around the home for areas where water supply lines are located in unheated areas and take measures to prevent the flow of cold air in these areas. Look under the house, in the basement, crawl space, attic, garage, and under kitchen and bathroom cabinets. Both hot and cold water pipes in these areas should be insulated. A hot water supply line can freeze just as a cold water supply line can freeze if water is not running through the pipe, and the water temperature becomes cold. Insulation supplies are available at your local home improvement or hardware store.

• If your water pipes do freeze, never try to thaw a pipe with an open flame or torch. Always be careful of the potential for electric shock in and around standing water.

• If you will be away from your home, keep the thermostat at a reasonable temperature to make sure all areas with water pipes are kept above freezing. Insulate pipes in unheated spaces. Hardware or building supply stores carry insulation designed to keep pipes in these areas from freezing.

What if I lose the heat source in my home?

If you are staying in your home, or will be monitoring your home frequently, allow a faucet to drip cold water slowly. At a minimum, the dripping faucet should be the one that is the greatest distance from your main water cutoff valve. Also, consider allowing a slow drip in areas that are least protected from the cold, such as basements, crawl spaces, attics, the garage.

As mentioned above, if your water pipes do freeze, never try to thaw a pipe with an open flame or torch. Always be careful of the potential for electric shock in and around standing water.

What do I do if my water meter freezes?

If you suspect you have a frozen water meter, call us for help. Do not attempt to thaw the water meter yourself as this can result in extensive damage. Questions and Answers

Q - How could a sewage backup affect me?

A - Sewer backups result from a blockage in the county's sanitary sewer line or the private sewer line that connects your home to the county system. If a blockage occurs, wastewater may enter your home through floor drains, showers or toilets in the basement.

Q - What causes sewage backups?

A - Accumulation of fats. Oil and grease and root intrusion in both private and public sewer lines are major reasons for backups. Also, flushing items down the toilet that are too large for sewer lines to handle - such as toys and sanitary napkins - can cause backups. Another cause of blockages within the country's system is vandalism. Leave, sticks, rocks, bricks, clothing, toys and trash have been found in sanitary sewer manholes.

Q - What can I do to help?

A - Call the Wastewater Collection Division (703-323-1211, TTY 711) immediately if you notice any vandalism of sewer lines or manholes. This way, the debris can be removed before it causes a backup.

Avoid putting cooking oils and grease down your garbage disposal or any household drain. Not only could it accumulate in county lines, but also it could build up in your own lines, eventually requiring the services of a plumber.

Do not flush disposable diapers or sanitary napkins down the toilet even if the labels indicate that you can do so. Besides stopping your sewer lines, these items could damage your plumbing system.

Q - What should I do if sewage begins to back up into my home?

A - Call the **Wastewater Collection Division's 24-hour Trouble Response Center at 703-323-1211, TTY 711**. Our staff will inspect the county's sewer line. If the problem is in the county's sewer line, the county will take corrective action.

Q - What does the county do to prevent sewage backups?

A - Fairfax County's Wastewater Collection Division is responsible for operating and maintaining more than 3,300 miles of sanitary sewer, 65 pumping stations, and 59 flow meters. Our staff regularly clean the county's sewer lines to remove blockages caused by tree roots and greases - two major causes of sewer backups.

Q - Who is responsible if the blockage is located in a customer's service line?

A - Property owners are responsible for maintaining the private sewer line that extends from their property to the county sewer system, including the connections to the sewer. Therefore, property owners are responsible for any damages resulting from blockages in the private sewer line.

Q - Who is responsible if the blockage occurs in a county sewer system?

A - If the blockage occurs in a county sewer line, the Wastewater Collection Division will take corrective action. You may be reimbursed for any damage to private property, except in the case of vandalism to the county sanitary sewer system. Fairfax County's **Risk Management Division (703-324-3040, TTY 711)** handles all claims for reimbursement for damaged property.

Q - Will my insurance cover any damage resulting from sewage backups?

A - In the majority of cases, a special rider is needed to your homeowner's or renter's insurance policy to cover damages related to sewage backups or water damage. This optional coverage is available from your insurance provider. However, you must usually request it, as it is not automatically included in most policies.

WHO SHOULD I CALL TO REPORT A SEWAGE BACKUP?

Emergency crews from the county are on call 24 hours a day to assist you. In an emergency such as wastewater line backup contact the Wastewater Collection Division.
