
We lost a couple of wonderful "old timers"- Lendell Steele (left) and Floyd "Fred" Cline (right). Our community has been diminished by their passing!

The Origins of Lake Accotink

From the Historical Marker Data Base

Indigenous People. The original inhabitants of the lands around Accotink Creek lived as semi-sedentary hunters and gatherers who moved seasonally to follow game. These peoples spoke varying forms of the Algonquin language. The river system provided them with a wealth of resources as well as a means of transportation. The waters teemed with fish and deer and other animals were drawn to its banks. Gathering and farming were also important lifeways. Corn and beans were combined as "succotash" making up half their diet, which was also supplemented with wild berries and nuts. Early peoples were also drawn to the area due to the prolific amount of quartz and other materials from which they could make tools, including projectile points and stone scrapers. With European advancement along the waterways beginning in the early 17th century, the Native Americans were slow-ly pushed off their lands.



Bridging the Gap. The railroad trestle was built as part of the Orange and Alexandria Railroad in 1851. The line connected the port city of Alexandria with the interior of the state, which allowed for a more efficient exchange of raw materials and imported goods. During his 28 December 1862 raid on nearby Burke's Station, Confederate General J.E.B. Stuart dispatched 12 men under the command of Fitz Lee to burn the railroad bridge over Accotink Creek. Stuart also tore up the rails and cut telegraph lines before withdrawing. The trestle was later rebuilt and continued carrying Union supplies for the duration of the war. In 1917 it was rebuilt out of wrought iron and again from concrete and steel.

Camp A. A. Humphreys. In 1912, the War Depart-

ment purchased a plot of land that had once been part of the Belvoir estate built by William Fairfax in 1741. The land was meant to serve as a summer camp and rifle range for the engineering corps stationed at nearby Washington Barracks in Washington, DC. With the outbreak of WWI, the camp was turned into a more permanent establishment and named Camp A. A. Humphreys, after a distinguished Civil War engineer. With plans to permanently move the Army Corps of Engineers there in 1919, a water source was needed.



Springfield Dam. Originally known as the Springfield Dam, when it was first built in 1918, the dam created Lake Accotink as a safe, stable water source. The dam originally cost \$100,000 to build and was contracted to the Amburson Construction Company. The reservoir it created covered 110 acres and was 23 feet deep. Because of siltation from storm water runoff, the lake has now shrunk in size. Today Camp A. A. Humphreys is known as Fort Belvoir.



With the development of Springfield during the 1950s, Fort Belvoir opted to move its water source to the Alexandria Water Company. With Lake Accotink no longer needed for a water source, military officers used it as a retreat until the Fairfax County Park Authority leased in in 1960. The part Authority purchased the land for half price in 1965 under the federal "Land to Parks" program.

Let Your Voice Be Heard! Comment on the Future of Lake Accotink!

In October of 2019, after several years of meetings between citizens and the Fairfax County Board of Supervisors (BOS), the Board voted unanimously to dredge Lake Accotink to a depth of 8 feet. Several years of studies and deliberations have gone on since then, no dredging has taken place, and now in 2023, the Fairfax County Park Authority (FCPA) and Department of Public Works and Environmental Services (DPWES) have made a recommendation to the Board of Supervisors that Lake Accotink **be allowed to fill in with silt and no longer dredge it.** If this recommendation is accepted by the Board of Supervisors, Fairfax County's beloved Lake Accotink might not be a lake in the future.

There are several reasons FDPA and DPWES came to this conclusion. "The condition of Lake Accotink today is largely due to rapid development within the Accotink Creek watershed in the mid-20th century, which resulted in increased stormwater runoff that eroded streams and sent large amounts of sediment into the U.S. Army drinking water reservoir that became Lake Accotink," one analysis reads. Also, the cost of dredging the lake went from 30 million in 2019 to 95 million in 2023. The cost of follow up dredging for the next 20 years is predicted to be 300 million, making the total projected cost to be 395 million.

If you, like many other residents who don't want to lose Lake Accotink, think there must be alternatives to letting the lake fill up with silt and become a wetlands area, please make the Board of Supervisors aware of your opinions. Let the BOS know what you think the benefits of maintaining Lake Accotink as a "lake" are. Let the BOS know what Accotink Lake means to you and your family.

Trails for Youth (TYO) Springs Forward!

As spring 2023 comes into an early bloom, TrailsforYouth.Org (TYO) is preparing for lots of fun in nature for local youth. However, the changing of the season is bringing lots of changes to local parks and our organization.

TYO utilizes Brookfield Park and Lake Accotink as two of our main resources to teach you to overcome obstacles on the trail and in life. The existing trail connecting the two parks is an old legacy trail that needs lots of work to sustain, in particular as it crosses the creek numerous times. The masterplan for Brookfield Park includes a trail that would replace the existing trail and be safer and easier to maintain plus it would not cross the creek. TYO and the Mid-Atlantic Off-Road Enthusiasts (MORE) have both human capital and funds to create this trail and are waiting for the Park Authority to give us the go ahead. The Park's hesitation is towards maintenance of the trail, and both TYO and MORE have decades of experience providing volunteer trail maintenance. Once completed, walkers, hikers and bikers will have a direct route to the CCT without having to use local trafficked roads like Highland St. Until the Park gives the go-ahead, the new trail cannot be built. We are hoping the community will back TYO and MORE on getting this project moving forward.

TYO joins the many residents who are anxious about the pending decision on silt removal at Lake Accotink. TYO is also anxious for the completion of the new trail behind the dam. During the interim closure, we have had to enter the park trails via Danbury Forest Drive. which required either driving or riding with groups of youth on the road. Once the new trails are completed (both in Brookfield and at Lake Accotink) TYO and other residents of the SCA area will be able to have safer rides with less of an environmental footprint.

Finally, TYO itself is changing, we are downsizing and moving to a Board of Directors led organization. We still are planning 50 events annually for local youth but will no longer have a full time Executive Director. The Board is responding positively to this new challenge and are taking it head-on. Ultimately our goal remains the same, provide opportunities that wouldn't exist for our program youth if not for TYO. Please join us as we do and state your support for us, and our local parts



The Loss of Two Springfield Long-Time Residents

Lendell E. Steele May 5, 1928 – November 15, 2022



Born and raised in small towns in North Carolina, Lendell came from very humble beginnings. He worked hard his whole life...from selling candy bars door-to-door as a child during the depression to milking cows, hauling ice and coal, to analyzing fertilizer samples, serving as a mill worker and dishwasher in college cafeterias. He put himself through college, including Mars Hill University, GWU and American University, graduating with a B.S. in Chemistry and Masters in Economics.

As an officer in the Air Force and Reserves, he worked in the atomic, biological & chemical warfare field, leading to a 39-year career with the Naval Research Lab as a nuclear physicist, researcher, and expert in the field of radiation safety of materials. He authored and edited numerous books in his field and travelled the world making presentations on these topics to colleagues. He also served as Chairman of the Board of the American Society for Testing and Materials, where he was recognized for his

knowledge and expertise. He served as a consultant in the nuclear field with the International Atomic Energy Agency.

Lendell and his wife of 65 years Rowena, moved to Springfield, Virginia in 1953, settling in the Crestwood neighborhood as original homeowners, where they raised their four daughters. Lendell taught his girls to swim at the Springfield Swim Club, where he also cheered on his grandson at dive meets.

Lendell is survived by his loving daughters, their husbands, three grandchildren, six great grandchildren, nieces and nephews, a sister, and friends and neighbors who loved him dearly.

Floyd Frederick (Fred) Cline died on March 5, 2023, as a result of respiratory complications while battling pneumonia. Fred was born on April 19, 1937 in Xenia, Ohio. He served our Nation with distinction during a twenty-year career in the U.S. Army spending fourteen of those twenty years overseas completing two tours in Vietnam, two tours in Korea and two tours in Germany. On his first tour in Germany, he met and married his beloved wife, Renate on May 13, 1960. Fred began his second career of twenty years in 1976 on the Capitol Police Force where he served with distinction in a variety of

assignments. In his retirement, Fred worked selflessly in support of American Legion Post 176 in Springfield Virginia. While there, he served as the Sergeant at Arms for many years and was selected as the Sergeant at Arms Emeritus in 2021. Additionally, he served as Member At Large on the Post Executive Committee. For years, Fred served as an election official at Crestwood School and as an unofficial greeter at SCA meetings. He brought this same level of commitment to his home church, the Chapel at Fort Belvoir Virginia where he volunteered as the Usher Coordinator, the administrator for the men's ministry, Belvoir Men of Faith and with the AWANA children's ministry. Fred was a man of quiet faith whose life of loving service reflected the love of Jesus Christ. Fred will be sorely missed but we take comfort in the words of the Apostle Paul who reminds us with confidence that to be absent from the body is to be present with the Lord.

Fred is survived by his wife of 62 years, Renate and his younger brother Steven D. Cline of Xenia Ohio. Fred's middle brother, Jerry Jr., predeceased Fred a number of years ago. Both brothers blessed Fred with many nieces and nephews who live in Michigan and Texas. He is also survived by scores of his brothers and sisters in Christ whom he loved and served and who in turn loved him.



Backyard Chickens?

With egg and poultry prices increasing, you may be considering keeping chickens on the same lot as your single-family dwelling. However, there are Zoning Ordinance requirements to consider. For example, the keeping of chickens is only allowed on lots two acres or more in size, and structures for chickens must be located at least 50 feet from all lot lines. Owners of lots that do not meet these Zoning Ordinance requirements can only keep chickens with approval of a special permit by the Board of Zoning Appeals (BZA). Through a public hearing, the BZA can consider whether modifications can be approved (such as smaller lot size) if compatible with the adjacent area. The BZA may not approve a special permit to allow roosters. Roosters are only permitted as part of a bona fide agricultural operation.


